- 2) Site map must include the distance of the each of the proposed Marker Balls in relation to the nearest CenterPoint Energy structure(s) and subsequent Maker Balls. All CenterPoint Energy transmission structures must be labeled with their associated structure numbers. All CenterPoint Energy distribution structures must demonstrate the distance between itself and the center of the nearest road. Map must also include north arrow & scale; noted the location(s) and nearest public street intersection(s) with street names labeled.


After the receipt of all requested information, CenterPoint Energy requires a minimum of four (4) weeks for an initial review of the request. In any event where the relocation or removal of CenterPoint Energy electrical facilities is necessitated by this request, an extended time period will be required, and the cost of such relocation(s) will be borne by the requestor and such costs must be paid to CenterPoint Energy in full before the request is granted. CenterPoint Energy's Asset Planning & Optimization Division will review the proposed installation of the Marker Balls. If this Marker Ball application is approved, then a license agreement and construction estimate will be mailed to the Requestor. The agreement must be signed and returned along with full payment before construction begins.
